Ações da Rivian saltam após acordo de investimento do Grupo Volkswagen

As ações da Rivian soaram depois que o Grupo Volkswagen, o gigante alemão do setor automotivo, concordou vai de bet bônus R\$10 investir até R\$5bn na fabricante de carros elétricos apoiada pelo Amazon.

O Volkswagen investirá inicialmente R\$1bn como parte de uma parceria com a Rivian para formar uma nova joint venture controlada igualmente para compartilhar arquitetura e software de veículos elétricos, conforme as empresas disseram na terça-feira.

Na Bolsa de Valores de Nova York, as ações da Rivian saltaram 36% durante as negociações fora do horário comercial após o anúncio.

O acordo representa uma vitória significativa para a Rivian, que enfrenta perdas profundas à medida que tenta aumentar a produção de seus caminhões e utilitários esportivos elétricos.

Enquanto as startups de veículos elétricos têm enfrentado uma desaceleração na demanda devido às taxas de juros altas e às reservas de caixa vai de bet bônus R\$10 declínio, os fabricantes de automóveis tradicionais tiveram dificuldades vai de bet bônus R\$10 construir veículos a bateria e softwares avançados.

Oliver Blume, CEO do Grupo Volkswagen, disse: "Através de nossa parceria, traremos as melhores soluções para nossos veículos mais rápido e a um custo menor ... Estamos fortalecendo nosso perfil de tecnologia e nossa competitividade."
